

As part of Livingston master-planned community, Brookfield Residential incorporated the Livingston Homeowners Association (LHOA), which is responsible for the maintenance of certain amenities within the community. These amenities complement Livingston's overall development concept and clearly distinguish Livingston from other communities.

Annual fees are not optional to ensure sustainability and to cover operating and maintenance costs of the Association, including the Livingston amenities. Each property will be subject to an annual charge evidenced in the form of an Encumbrance registered on title, securing payment to the Association. The maximum amount of such Encumbrance payment for each lot and unit is \$400.00 per year, plus an adjustment by percentage increase, if any, of the "All Items" Consumer Price Index (CPI), plus GST, as per the Encumbrance and Articles of Association. **The annual payment for fiscal year April 1st- 2026-March 31st-2027 is \$455.00 + GST.**
